PAKISTAN VISA INFORMATION

All US citizens require visa to visit Pakistan. Contact Embassy/Consulates for details. FOR ALL TYPES OF VISA, PLEASE COMPLETE THIS APPLICATION (see reverse side). All other nationals please contact Embassy or respective Consulates for visa requirements and other information.

REQUIREMENTS

ALL TRAVELERS:

1. **Proof of legal permanent residence in USA (Alien Registration Card).**
2. **Proof of residence in this jurisdiction, Washington, DC**
3. **2-passport size photos.**
4. **Verification of permanent full time employment.**
5. **Verification of financial support.**
6. **Closed round-trip ticket. (Xerox copy)**
7. **Necessary visas to countries of further destination.**
8. **Passport valid for at least six months from travel date.**
9. **Visa fee for US passport only is \$ 45.00, payable in the form of money order to The Embassy of Pakistan. Cash and Personal checks are NOT acceptable.**

Business Visa: A letter of invitation and letter from the sponsoring company are required.

The Embassy of Pakistan and Pakistan Consulates in New York & Los Angeles will exempt US citizen of Pakistani origin from the requirement of visa restrictions and police registration. For this purpose exemption stickers valid for five years need to be affixed for a fee of US \$ 45.00. In order to avail this facility along with their immediate family members the applicants must provide either old Pakistani passport or Pakistan National Identity Card in original. **For children born in USA, only father's Pakistani ID is applicable.**

If passport is submitted by mail, they must be accompanied with a FULLY STAMPED SELF-ADDRESSED ENVELOPE for return of the passport by certified, Registered or Express mail (do not use metered stamps).

ALL FEES ARE NON-REFUNDABLE EVEN IF VISA IS DENIED.

HEALTH REQUIREMENTS.

CHOLERA: Vaccination is required for arrival from infected areas.

SMALL POX: A certificate is required from all travelers who, within the preceding 14 days, have visited a nation or any part of nation, which is infected. Pakistan considers the nations and areas, which are included in the former endemic zones, as infected areas.

AIDS (HIV): AIDS free (HIV) certificate is required from applicants staying in Pakistan for more than one year.

YELLOW FEVER. A certificate is required from all travelers irrespective of age coming from any part of nation, which is endemic for yellow fever.

OFFICE HOURS:

Visa applications will be accepted between the hours of 09:30 to 12:30, Monday through Friday. Passport will be delivered after two business days.
