Effective September 1, 1986 all US citizens will require visa to visit Pakistan. This include tourists. Contact Embassy/Consulates for details.

**FOR ALL TYPES OF VISA, PLEASE COMPLETE THIS APPLICATION** (see reverse side).

All other nationals please contact Embassy or respective Consulates for visa requirements and other information.

**REQUIREMENTS**

**ALL TRAVELERS:**

1. Proof of legal permanent residence in U.S.A. (Except U.S. citizen)
2. Proof of residence in this jurisdiction, Washington, D.C.
3. 2 passport size photos.
4. Verification of permanent full time employment.
5. Verification of financial support.
6. Closed round-trip ticket. (Xerox copy)
7. Necessary visas to countries of further destination.
8. Passport valid for at least six months from travel date.
9. Visa fee for U.S. passport only is \$ 45.00, payable in the form of money order to The Embassy of Pakistan Cash and Personal checks are unacceptable.

**NOTE: Processing time may vary for different countries. U.S. CITIZENS OF PAKISTANI ORIGIN MUST PROVIDE ORIGINAL PAKISTAN NATIONAL IDENTITY CARD IF REQUESTING FIVE YEARS MULTIPLE ENTRY VISA, OTHERWISE 3 MONTHS VISA WILL BE ISSUED.**

If passport are submitted by mail, they must be accompanied with a **FULLY STAMPED SELF-ADDRESSED ENVELOPE** for return of the passport by certified mail (do not use metered stamps). Fee is payable in US Postal money orders or cashiers checks to the Embassy of Pakistan. Please do not send cash or personal checks. **ALL FEES ARE NON-REFUNDABLE EVEN IF VISA IS DENIED. HEALTH REQUIREMENTS.**

**CHOLERA:** Vaccination is required for arrival from infected areas.

**SMALL POX:** A certificate is required from all travelers who, within the preceding 14 days, have visited a nation or any part of nation which is infected. The nations and areas which are included in the former endemic zones are considered by Pakistan as infected areas. **AIDS (HIV):** AIDS free (HIV) certificate is required from applicants staying in Pakistan for more than one year. **YELLOW FEVER.** A certificate is required from all travelers irrespective of age coming from any part of nation which is endemic for yellow fever.

**NOTE:** To provide Consular facilities all over USA Consular work must be submitted at their regional Consular Offices. Out of jurisdiction requests will be denied and returned immediately.

**OFFICE HOURS:**

Visa applications will be accepted between the hours of 09:30 to 12:30, Monday through Friday. Passport will be delivered after two days for regular visa, and passports for urgent visa will be delivered on the next working day.

## PAKISTAN VISA POLICY

### INSTRUCTION TO VISA APPLICANTS.

#### General:

1. Applications are accepted at the counter from 9:30 A.M. to 12:30 P.M. Monday through Friday, except holidays.
2. Passports received at the counter will normally be available for collection after two days for regular visa, and passports for urgent visa will be delivered on the next working day, between the hours of 11:00 A.M. and 12:30 P.M.
3. If a passport is required to be returned by mail, a self-addressed postage paid return envelope should accompany the application.
4. Exact visa fees should be paid in cash or by money order/bank draft/certified check drawn in the name of the Embassy of Pakistan, Washington, D.C. Personal checks are not accepted.
5. Visa fee once charged/excess payment if any cannot be refunded.

#### TYPES OF VISAS:

1. **TOURIST VISAS:** For sight-seeing/vacation, valid for one entry and three months stay from the date of initial entry.
2. **ENTRY VISAS:** For business, meeting friends and relatives; valid for one entry and three months stay.  
**REQUIREMENTS:** One application form with two photographs. A letter from the sponsoring firm/organization indicating the nature of the applicant's business, probable duration of stay, the places and firms in Pakistan he/she intends to visit incorporating therein guarantees to meet maintenance expenses of the applicant in Pakistan and his/her journey out of Pakistan.
3. **STUDENT VISAS:** For bonafide students to pursue studies in recognized educational institutions in Pakistan. Valid for one entry. **REQUIREMENTS:** One application form and two photographs. A letter from a recognized educational institution in Pakistan confirming admission of the applicant and duration of study. Evidence of financial arrangement made for maintenance in Pakistan.
4. **VISA FOR RESEARCH SCHOLARS:** Valid for one entry and duration of stay as permitted by the Government of Pakistan. **REQUIREMENTS:** One application with two photographs. Detailed synopsis of the proposed research project, countersigned by the sponsoring institution in Pakistan. Evidence of financial arrangements made for maintenance in Pakistan.
5. **TRANSIT VISAS:** Transit visa is valid for single journey and maximum of two weeks stay and is good for bonafide transit only.

#### NOTE:

1. Special visa application forms are required for nationals of India.
2. A passport must be valid for at least six months.
3. A husband and wife holding a joint passport should submit separate visa applications, but only a single fee is charged. If minor children are included in the same passport, their details should be given on the separate visa form. A child traveling on a parent's passport who has reached the age of 12 years should submit a separate application with fee.

**HEALTH REGULATIONS:** Persons coming from or through yellow fever infected areas are required to be in possession of a valid certificate of vaccination against yellow fever.
